

JCSU Ordinary General Meeting (OGM) - Minutes

Meeting opened at: 18:07

Order of Business

1.0 Election of a Chair

- AP (Secretary) nominated AM (President) to chair the meeting, and this was accepted without opposition.

2.0 Report from the JCSU Executive Committee

- AM said that he had compiled a written report, outlining the various projects that different members of the Committee have been working on since their election: ICSU Executive Committee Report LT 2024.
- He asked whether anyone present had anything that they wanted to ask about this. No one did.

3.0 Questions to the JCSU Executive Committee

- No questions were posed to the JCSU Executive Committee.

4.0 Motions

- Motion 1: To increase the budget of the Jesus College Basketball Club
 - Uday Singh read out the motion as **proposed**.
 - He admitted that there had been an oversight on his part, however he explained that this was because the expenses that the Basketball Club would incur throughout the year had not been expressed during his handover.
 - He also said that Blues players were only permitted to play for the College team during Cuppers. Therefore, if the budget was not increased, this community aspect of the club would be lost.
 - Due to this oversight during handover, a smaller budget than normal was requested and approved, hence missing out the crucial league fees.
 - Krish Nanavati **seconded** the motion.

- He said that all the money the Basketball Club had spent so far was reasonable. It was purely for equipment, matches and pitch hire. No money had been used for socials.
- He added that, if the motion was not passed, there was a danger that the Club may die out. Because senior members would leave, there would be no handover or continuity and the club would therefore take considerable time to resume.
- No objections were made. The motion was **PASSED** with unanimous vote.

5.0 Any Other Business [AOB]

- Nothing was raised.

Motion 1: To increase the budget of the Jesus College Basketball Club

Proposer: Uday Singh Seconder: Krish Nanavati

The Jesus College Student Union notes:

- 1. That the Jesus College Basketball Club has overspent its allocated budget £1840.
- 2. That the Jesus College Basketball now has insufficient funds to finance the £275 payment required for league fees.
- 3. That, in previous years, the Jesus College Basketball Club operated with a higher budget which covered expenses such as league fees without any issues.
- 4. That a failure to increase the budget will result in the demotion of the Jesus College Basketball Club by one league, and its exclusion from Cuppers.

The Jesus College Student Union believes:

1. That, due to the strong interest and performance of the Club in Cuppers, its budget should be increased without delay.

The Jesus College Student Union RESOLVES:

1. To make an additional payment of £275 to the Jesus College Basketball Club so that its budget is increased to £2115.
